Parade Guidelines

**Registration deadline is November 10, 2018.** Late entries will be assessed a \$25 non-refundable entry fee. ALL ENTRIES must be pre-registered.

Parade entries must be in staging area no later than 1 hour to start of parade. After this time no entry into the parade will be permitted. There will be a mandatory meeting of all entrants 30 minutes prior to the start of the parade.

No throwing or tossing of candy or souvenirs, etc. Must be handed out by walkers.  
NO HOT RODDING, BURNOUTS, SIRENS OR OTHER LOUD NOISES.

All floats must have significant Christmas decor. No Santa suits are allowed to be worn.

Any of above actions will result in removal from parade and future parades.

Those driving a motor vehicle must have a valid driver's license.

Tractors are an exception if accompanied by an adult with a valid license.

No ATV's unless they are pulling a float or trailer. Stand alone vehicles will not be permitted – this includes golf carts, go carts, 4 wheelers, mules/rangers/side-by-side ATV's
